- Maintain active licensure to practice mental health counseling in the State of Utah (therapist employee is responsible for all fees associated with maintaining their licensure)
- Associate license in good standing

Compensation

- \$45 p er c linical hour p re-licensed l evel c linician.
- \$47 per clinical hour if you are certified or pursuing a certification (i .e. EMDR, I FS, SP).

<u>Therapist Employee Meetings:</u> Employee meetings are paid at a rate of \$20 per hour for part-time or full time pre-licensed or licensed W2 employees.

We are pleased to offer complimentary training sessions to our therapist employees. Please note that while the training itself is provided at no cost to you, your attendance is voluntary and unpaid during the training hours. We offer complimentary supervision to our pre-licensed therapist employees. Please note that supervision hours are unpaid.

- Clinical s upervision & training at no cost to full time or part time W2 therapist employees.
- Support and collaboration with other therapists during clinical team meetings.
- On site professional development and training at no cost to the employees.
